13th Masters' International SPRINT GAMES 2022 29th and 30th of January 2022 Max Aicher Arena Inzell / Germany

The competition is to be held in accordance with the following conditions of contest, the Regulations of the International Skating Union (ISU) and the Regulations of the International Masters' Speed Skating Committee (IMSSC) at the 400 m covered standard speed skating track of the Max Aicher Arena (MAA) in Inzell on artificial ice. This competition is a regular event of the International Masters' Competition Calendar of the IMSSC.

1. Distances and combination

Ladies and Men: 500 m, 1000 m (first day)
500 m, 1000 m (second day)
four-distance sprint combination

2. Age Groups

The competitions take place in five year age groups as follows.

3. Eligibility

To be eligible the skater must be member of a national speed skating federation recognized by the ISU and must have a license of his/her federation.

4. Participants limitation

The competition is restricted to 200 skaters. The following nations' quota list was defined and confirmed by the IMSSC Members:

5. Limit Times

According to IMSSC Rule 3.1.6, every participant has to inform the national IMSSC Member of his (her) most recent time on the 500 m. It is the responsibility of the IMSSC Member to accept the times. If the applicable time (500 m for the Sprint Games) does not meet the Maximum Time as laid down in Rule 3.1.7 (Maximum Time Table – see below) the participant cannot take part in the Sprint Games unless the national IMSSC Member decides otherwise in a written consent.

6. Drawing, Classification

Drawing will be held on January 28th 2022, Friday, at 11.30, at the stadium in the office 1st floor (Reichenhaller Straße 79, 83334 Inzell).

The drawing is carried out according to the Constitution and Regulations 2020/2021 of the International Masters' Speed Skating Committee (IMSSC) – ver.2.0 under Rule 3.5 Drawing and Ranking and paragraph "Drawing Sprint Competitions".

A skater who completes all distances successfully and obtains the lowest total of points in her/his five-year age group wins the four-distance competition in that group.

7. Prices and Minutes

All participants, who skate successfully the four distances contest, obtain a certificate, a medal and minutes including end times. The Complete Protocol (including start times, lap times, accumulated lap times and end times) can be found on the website <https://www.dec-inzell.de>.

10. Entries

Generally the entries are accepted in chronological order. However, Finland (FIN), The Netherlands (NED), Norway (NOR) and Russia (RUS) will make their entries after a qualification process.

You will get a confirmation by e-mail that your entry has been received by the Organizer. However, this message does not confirm your participation. The skaters get informed only on the internet <https://www.dec-inzell.de/events/wettkampfkalender/> whether they can take part in the competition or not (list of accepted competitors). An update takes place every week on Tuesday.

The registration deadline is January 10th 2022 for all nations.

After the qualification process the Participant Lists and Waiting Lists from FIN, NED, NOR and RUS must be made the entries by using and submitting the Electronic Entry Form until January 10th 2022 at the latest. Look under item 10.) <https://sscm.speedskatingnews.info>

Any unused quotas per January 10th will be distributed among those Nations having more entries than Quota (i.e. skaters on Waiting List) in relation to their original quota.

If an entered skater is prevented from participation by illness, injury or other unforeseen cause, he/she may be substituted by another skater from the Waiting List of the same country until the Team Leader Meeting before the drawing.

11. Entrance Fee

The entry fee is a fixed amount of 125,00 Euro per person. The entry fee includes the welcome drink and the Closing Banquet (look under item 12.) It has to be paid via bank transfer or via PayPal, to the account mentioned below. Official training periods for Masters' (look under item 8. in schedule) must be paid. Only the warm up on Saturday and Sunday is free!

15. COVID-19 rules

The current official regulations on Covid-19 allow the competition to take place.

We have published the applicable requirements and information on the [Max Aicher Arena website](#).

In case of a new situation with the possible ban on holding the competition, we will refund the paid fees. Only an organizational expense of € 5 will be retained.

The 2G+ regulation (vaccinated, recovered including Antigentest not older 24h hours or vaccinated with booster) is currently in force in the arena.

The 2G+ rule currently applies to the Masters banquet (vaccinated, recovered including Antigentest not older 24h hours).
